**Glenview Incident Summary  
November 26, 2024**

**Incidents:**

**24-49968                      Harassment by Telephone**

On 11/21/2024 at 1239 hours, a resident of the 1700 block of Glenview Rd reported that a resident of the 4600 block of N. Seminole Dr has been calling repeatedly and speaking nonsensical things about the FBI. A prior report was made for them doing the same thing.

**24-49999                      Identity Theft**

On 11/21/2024 at 1948 hours, a resident of the 3200 block of Greenbriar Dr reported that their employer informed them that someone applied for unemployment benefits in their name with the State of Illinois. They will utilize their current credit monitoring services as well as make a report with the State. Complaints will be signed.

On November 22, 2024, at 2347 hours, the homeowner of the residence in the 400 block of Brook Lane, reported between 1200 hours and 2342 hours, an unknown offender forced entry into their residence, ransacked the office and bedroom areas of the house and removed \$52,000.00 in cash and \$3,000.00 worth of jewelry.

On November 22, 2024, at 2250 hours, a resident from the 3800 block of Glenview Road was cited under the Village Ordinance for Disturbance by Animal after a barking dog complaint. There were numerous previous contacts with the male regarding barking dog complaints.

On November 23, 2024, at 1742 hours, the resident from the 4100 block of Blake Lane advised on November 15, 2024, at 1522 hours, they received a phone call from an unknown person who claimed to be their son. The unknown caller told the resident that their son was arrested and needed \$14,000.00 to bond out. The resident was instructed to withdrawal the money from their bank which they did. The resident was advised the money would be picked up by an unknown person at an unknown time. Family members verified the son was safe then called the Glenview Police. No one showed up to collect the money.

On November 22, 2024, at 1247 hours an employee a hotel in the 1800 block of Milwaukee Avenue, reported a female adult guest was causing a disturbance at the hotel by yelling and threatening other guests and employees. The female who was highly intoxicated was contacted and transported to Glenbrook Hospital by Glenview Fire for treatment.

The victim then received texts containing images of deceased individuals and then a phone call from an unknown male with a Dominican accent who demanded money. On 11/24/2024 at 1331 hours, a resident of the 700 block of Waukegan Rd reported being texted by a staffing agency through WhatsApp, with a job advertisement to sell packages. The job required them to pay a difference in customer fees and an algorithm would get them paid after. They paid approximately \$8,000-\$9,000 in cryptocurrency before realizing it was a scam. On 11/24/2024 at 1914 hours, a resident of the 2800 block of Parkside reported purchasing a Cartier brand watch from a social media page. They paid \$6,000 through Zelle and their Chase Bank account and received a watch in the mail with a certificate. They brought it to the Cartier store and they verified the certificate did not match the watch and that it could not be authenticated. They requested a refund from the company which was denied and the company ceased communication. Complaints to be signed.

On 11/24/2024 at 2017 hours, two employees of a business in the 3800 block of Willow Rd got into a verbal altercation over putting dishes away. They each stated the other had put their fists up as a threat to fight. The argument did not turn physical and there were conflicting statements. No complaints and parties separated.

**24-50565                      Deceptive Practices**

On 11/25/2024 at 1154 hours, a Libertyville resident received an email from which they believed was her boss. The email gave them instructions to purchase gift cards and requested they provide their personal cell phone number so they could communicate through text. They followed the instructions in the email and purchased \$2700 worth of Foot Locker gift cards at a business in the 2800 block Patriot Blvd. They sent photos of the cards and the scratched off PIN numbers. They spoke with their boss who told them that they have been scammed.

One of the males yelled to call the police, that the other male was trying to scam him out of money. He separated from the altercation and both males left the store. The offending vehicle was a black Infiniti, which fled northbound on Waukegan Rd and was later seen south on I-94. Complaints will be signed.
